Applications are now open for Batch 006 of the Myanmar Directors' Certification Program on 16th – 18th March 2020, brought to you by Myanmar Institute of Directors (MIoD).

The MIOD's Directors Certification Program (DCP) was launched in April 2019 in Myanmar, first ever formal director training Program with certification. The Program content is developed by Singapore Management University's well-known executive Program with MIoD as its local partner, where we aim to deliver executive training to a network of government and business leaders in Myanmar.

This unique 3-days Program (16th – 18th March 2020) is set within an Asian Businesses context and provides a well-rounded board-level view of key strategies and focal issues facing many companies in Myanmar.

This Program reviews the new Myanmar Companies Act (MCL) in the context of Directors roles and responsibilities including the regulatory requirements that Directors are required to follow as prescribed by the law. Per MCL, Director's liability is very new concept to Myanmar, the participants will hear about how to mitigate this.

Review of key challenges Myanmar companies are facing today while implementing strong corporate governance structure in place to attract more foreign direct investment into Myanmar. The participants will also look at family governance especially succession planning by reviewing case studies of well-known families in Asia.

Directors also need to understand the story behind the numbers, financial statement analysis, benchmarking of key financial indicators and ratios which are critical in understanding the financial health of companies, as well as review of well-known financial frauds and the lessons that Directors can learn from these past case studies.

This course will be very interactive with reviews of many case studies around Asian countries to enforce key learning points and engagement with fellow participants and trainers through work examples to upskill and equip the Directors of Myanmar companies with knowledge and ability to lead in the ever-changing times of Myanmar business landscape.

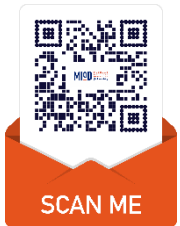
